Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is anticipated to occur in the middle of 2021.

Option Symbol: BPFH changes to SIVB1

Strike Divisor: 1

Contracts Multiplier: 1

New Multiplier: 100 (e.g., a premium of 1.50 yields \$150; a strike of 15 yields \$1,500.00)

New Deliverable Per Contract:

- 1) 2 SVB Financial Group (SIVB) Common Shares
- 2) Cash in lieu of 0.28 fractional SIVB Common Shares
- 3) \$210.00 cash (\$2.10 x 100)

Note: Once determined, the cash in lieu of fractional share portion of the option deliverable will remain fixed and will not vary with price changes of any security.

Pricing

Until the cash in lieu amount is determined, the underlying price for SIVB1 will be determined as follows:

$$\text{SIVB1} = 0.0228 (\text{SIVB}) + 2.10$$

Delayed Settlement

The SIVB component of the SIVB1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SIVB1 deliverable until the cash in lieu of fractional SIVB shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On April 27, 2021, Shareholders of Boston Private Financial Holdings, Inc. (BPFH) will vote concerning the proposed merger with SVB Financial Group (SIVB). If the merger is approved and consummated, each existing BPFH Common Share will be converted into the right to receive 0.0228 SIVB Common Shares plus \$2.10 Cash. Cash will be paid in lieu of fractional SIVB shares.
