Companhia Paranaense de Energia - COPEL (ELP) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each ELP American Depositary Share will be converted into the right to receive 0.20 (New) Companhia Paranaense de Energia - COPEL American Depositary Shares. The reverse stock split will become effective before the market open on April 28, 2021.
