On May 20, 2021, Shareholders of Shaw Communications Inc. (SJR) will vote concerning the proposed plan of arrangement with Rogers Communications Inc. If the plan is approved and consummated, each existing SJR Class B Non-Voting Participating Share will be converted into the right to receive 40.50 CAD net cash per share.

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated.
Contract adjustment is expected to occur in the first half of 2022.

New Deliverable
Per Contract: 100 x the USD equivalent of 40.50 CAD

Settlement in SJR options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
