Subject: Inphi Corporation - Cash In Lieu Settlement
Adjusted Option Symbol: MRVL1

Inphi Corporation options were adjusted on April 21, 2021 (See OCC Information Memo #48606). The new deliverable became 1) 232 Marvell Technology, Inc. (MRVL) Common Shares, 2) Cash in lieu of 0.3 fractional MRVL shares, and 3) \$6,600.00 Cash. Only settlement of the cash portion of MRVL1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$44.50 per whole MRVL share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.3 \times \$44.50 = \$13.35 \text{ per MRVL1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of April 21, 2021 through May 06, 2021, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the MRVL1 options are as follows:

New Deliverable

Per Contract: 1) 232 Marvell Technology Group Ltd. (MRVL) Common Shares
2) \$6,613.35 Cash (\$6,600.00 + \$13.35)

Strike Prices: Unchanged

CUSIP: MRVL: 573874104

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The MRVL component of MRVL1 exercise/assignment activity from April 21, 2021 through May 5, 2021, has settled through National Security Clearing Corporation (NSCC). The \$6,613.35 cash amount will be settled by OCC.

Pricing

The underlying price for MRVL1 will be determined as follows:

$$\text{MRVL1} = 2.32 (\text{MRVL}) + 66.1335$$

For example, if MRVL closes at 44.45, the MRVL1 price would be calculated as follows:

$$\text{MRVL1} = 2.32 (44.45) + 66.1335 = 169.26$$
