On May 21, 2021, Shareholders of Tribune Publishing Company (TPCO) voted concerning the proposed merger with a wholly-owned subsidiary of Tribune Enterprises, LLC, an affiliate of Alden Global Capital LLC. The merger was approved and subsequently consummated before the open on May 25, 2021. As a result, each existing TPCO Common Share will be converted into the right to receive \$17.25 net cash per share.

Settlement in TPCO options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## ACCELERATION OF EXPIRATIONS

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Tribune Publishing Company options whose expiration dates are after 6-18-2021 will have their expiration dates advanced to 6-18-2021. Expiration dates occurring before 6-18-2021 (e.g., Flex options) will remain unchanged.

All Tribune Publishing Company options will utilize a \$.01 exercise threshold.

Option Symbols: TPCO Existing Expiration: All months New expiration date: 6-18-2021

Existing American-style Tribune Publishing Company options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
