Pricing

Until the cash in lieu amount is determined, the underlying price for ICLR1 will be determined as follows:

$$\text{ICLR1} = 0.4125 (\text{ICLR}) + 80.00$$

Delayed Settlement

The ICLR component of the ICLR1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ICLR1 deliverable until the cash in lieu of fractional ICLR shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On June 15, 2021, Shareholders of PRA Health Sciences, Inc. (PRAH) will vote concerning the proposed merger with ICON plc (ICLR). If the merger is approved and consummated, each existing PRAH Common Share will be converted into the right to receive 0.4125 ICLR Ordinary Shares plus \$80.00 Cash. Cash will be paid in lieu of fractional ICLR shares.
