On June 15, 2021, Shareholders of Houston Wire & Cable Company (HWCC) voted concerning the proposed merger with OCDFH Acquisition Sub Inc., a wholly-owned subsidiary of Omni Cable, LLC. The merger was approved and consummated on June 15, 2021. As a result, each existing HWCC Common Share will be converted into the right to receive \$5.30 net cash per share.

#### **CONTRACT ADJUSTMENT**

**NEW DELIVERABLE  
PER CONTRACT:** \$530.00 Cash (\$5.30 x 100)

Settlement in HWCC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **ACCELERATION OF EXPIRATIONS**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Houston Wire & Cable Company options whose expiration dates are after 7-16-2021 will have their expiration dates advanced to 7-16-2021. Expiration dates occurring before 7-16-2021 (e.g., Flex options) will remain unchanged.

All Houston Wire & Cable Company options will utilize a \$.01 exercise threshold.

New expiration date: 7-16-2021

Existing American-style Houston Wire & Cable Company options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
