Subject: Grubhub Inc. - Cash In Lieu Settlement

Adjusted Option Symbol: GRUB1

Grubhub Inc. options were adjusted on June 15, 2021 (See OCC Information Memo #48849). The new deliverable became 1) 335 Just Eat Takeaway.com N.V. (GRUB) American Depositary Shares, and 2) Cash in lieu of 0.5 fractional GRUB shares. Only settlement of the cash portion of GRUB1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$16.34 per whole GRUB share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

 $0.5 \times 16.34 = 88.17 \text{ per GRUB1 Contract}$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 15, 2021 through June 22, 2021, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the GRUB1 options are as follows:

New Deliverable

Per Contract: 1) 335 Just Eat Takeaway.com N.V. (GRUB) American Depositary

Shares

2) \$8.17 Cash

Strike Prices: Unchanged

CUSIP: GRUB: 48214T305

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The GRUB component of GRUB1 exercise/assignment activity from June 15, 2021 through June 21, 2021, has settled through National Security Clearing Corporation (NSCC). The \$8.17 cash amount will be settled by OCC.

Pricing

The underlying price for GRUB1 will be determined as follows:

$$GRUB1 = 3.35 (GRUB) + 0.0817$$

For example, if GRUB closes at 17.58, the GRUB1 price would be calculated as follows:

$$GRUB1 = 3.35 (17.58) + 0.0817 = 58.97$$
