On September 14, 2021, Shareholders of Lydall, Inc. (LDL) will vote concerning the proposed merger with Outback Merger Sub, Inc., a wholly-owned subsidiary of Unifrax Holding Co. If the merger is approved and consummated, each existing LDL Common Share will be converted into the right to receive \$62.10 net cash per share.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.  
Contract adjustment is expected to occur in the second half of 2021.

**New Deliverable**  
**Per Contract:** \$6,210.00 Cash (\$62.10 x 100)

Settlement in LDL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
