The record date is September 2, 2021; the payable date is September 17, 2021. The NYSE has set September 20, 2021, as the ex-distribution date for this distribution.

Jackson Financial Inc. Common Shares began trading on a when issued basis on September 1, 2021 on the NYSE under the trading symbol "JXN WI".
