**Pricing**

Until the cash in lieu amount is determined, the underlying price for ZD1 will be determined as follows:

$$ZD1 = ZD + 0.333333 \text{ (CCSI)}$$

### **Delayed Settlement**

The ZD and CCSI components of the ZD1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the ZD1 deliverable until the cash in lieu of fractional CCSI Common Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

### **Background**

j2 Global, Inc. (JCOM) has announced a distribution of (New) Consensus Cloud Solutions, Inc. (CCSI) Common Shares. The distribution ratio is approximately 0.333333 of a CCSI share for each JCOM share held. The record date is October 1, 2021; the payable date is October 7, 2021. The NASDAQ has set October 8, 2021, as the ex-distribution date for this distribution. Cash will be paid in lieu of fractional shares. Prior to the opening of business on October 8, 2021, j2 Global, Inc. will change its name and trading symbol to Ziff Davis, Inc. (ZD).

Consensus Cloud Solutions, Inc. Common Shares began trading on a when issued basis on September 30, 2021 on the NASDAQ under the trading symbol "CCSIV".
