On October 26, 2021, Shareholders of Trillium Therapeutics Inc. (TRIL) will vote concerning the proposed Arrangement Agreement with PF Argentum Acquisition ULC, a wholly-owned subsidiary of Pfizer Inc. If the arrangement is approved and consummated, each existing TRIL Common Share will be converted into the right to receive \$18.50 net cash per share.

## **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated.

New Deliverable

**Per Contract:** \$1,850.00 Cash (\$18.50 x 100)

Settlement in TRIL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
