On December 1, 2021, Unitholders of Teekay LNG Partners L.P. (TGP) will vote concerning the proposed merger with Limestone Merger Sub, Inc., a wholly-owned subsidiary of Stonepeak Limestone Holdings LP. If the merger is approved and consummated, each existing TGP Common Unit will be converted into the right to receive \$17.00 net cash per unit.

#### **Contract Adjustment**

**Date:** Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur on December 31, 2021 or shortly thereafter.

**New Deliverable  
Per Contract:** \$1,700.00 Cash (\$17.00 x 100)

Settlement in TGP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
