On August 9, 2021, Shareholders of Loral Space & Communications Inc. (LORL) voted concerning the proposed transaction with Telesat Canada and its affiliates to combine Loral and Telesat into a new Canadian public company, Telesat Corporation. The transaction was approved and subsequently consummated on November 18, 2021. As a result, each existing LORL Common Share will be converted into the right to receive, at the election of the shareholder:

- One newly issued Telesat Partnership LP Unit ("Telesat Partnership Election"), or
- One newly issued Telesat Corporation Public Share ("Telesat Corporation Election").

LORL shareholders who failed to make an election shall be deemed to have made a Telesat Corporation Election, as described in the LORL/Telesat Joint Proxy Statement/Prospectus dated June 30, 2021 ("Proxy").

Elections have to be submitted to the exchange agent, Computershare Trust Company, N.A,. The election deadline was at 5:00 p.m. on the business day that is three business days prior to the date of the closing of the transaction. LORL Shareholders must observe all terms and conditions for the election as specified in the Proxy. It should be noted that it is unknown if shares may be delivered pursuant to an election under "Notices of Guaranteed Delivery" which allows delivery of LORL shares within a certain number of business days of submission of the notices. In all cases, Call option holders exercising in order to obtain stock for an election must exercise in sufficient time to be able to make valid delivery pursuant to the election procedures.
