On October 12, 2021, Shareholders of Covanta Holding Corporation (CVA) voted concerning the proposed merger with a wholly-owned subsidiary of Covert Intermediate, Inc., a subsidiary of funds affiliated with EQT Infrastructure. The merger was approved and subsequently consummated before the open on November 30, 2021. As a result, each existing CVA Common Share will be converted into the right to receive \$20.25 net cash per share.

#### **Contract Adjustment**

PER CONTRACT:** \$2,025.00 Cash (\$20.25 x 100)

Settlement in CVA options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Covanta Holding Corporation options whose expiration dates are after 12-17-2021 will have their expiration dates advanced to 12-17-2021. Expiration dates occurring before 12-17-2021 (e.g., Flex options) will remain unchanged.

All Covanta Holding Corporation options will utilize a \$.01 exercise threshold.

Existing Expiration: All months  
New expiration date: 12-17-2021

Existing American-style Covanta Holding Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
