Subject: Adjusted SuRo Capital Corporation – Determination of Deliverable
Adjusted Option Symbol: SSSS3

Adjusted SuRo Capital Corporation options were adjusted on November 16, 2021 and December 30, 2021 (See OCC Information Memos #49526 and #49804). The new deliverable became 1) 100 SuRo Capital Corporation (SSSS) Common Shares, 2) An additional number of SSSS Common Shares reflecting the stock dividend received by non-electing SSSS shareholders, expected to be valued at \$200.00, 3) Cash in lieu of fractional SSSS shares, if any, 4) An amount of cash equal to the long-term capital gains distribution of $\$0.75 \times$ the number of shares in the adjusted SSSS3 deliverable (100 SSSS shares described in item 1 plus the additional number of shares described in item 2). Settlement of the SSSS and cash components of SSSS3 options exercise/assignment activity were subject to delayed settlement.

OCC has been informed that the final distribution rate paid to non-electing shareholders in the distribution is 0.1493651979 SSSS shares per SSSS share held.

OCC has not yet been informed of a price to be used in determining cash in lieu of fractional shares.

Now that the distribution rate has been determined, OCC will require Put exercisers and Call assignees, during the period of November 16, 2021 through December 30, 2021, to deliver the appropriate number of SSSS shares.

Terms of the SSSS3 options are as follows:

New Deliverable

Per Contract:

- 1) 114 SuRo Capital Corporation (SSSS) Common Shares
- 2) Cash in lieu of 0.93651979 fractional SSSS shares
- 3) \$85.50 Cash ($\0.75×114)

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Strike Prices: Unchanged

CUSIP: SSSS: 86887Q109

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The SSSS component of SSSS3 exercise/assignment activity, which was delayed from November 16, 2021 through December 29, 2021, will settle through National Security Clearing Corporation (NSCC).

OCC will continue to delay the cash portion of the SSSS3 deliverable until the cash in lieu amount is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Pricing

Until the cash in lieu amount is determined, underlying price for SSSS3 options will be determined as follows:

$$\text{SSSS3} = 1.1493651979 (\text{SSSS}) + 0.8550$$

For example, if SSSS closes at 13.00, the SSSS3 prices would be calculated as follows:

$$\text{SSSS3} = 1.1493651979 (13.00) + 0.8550 = 15.80$$
