**Pricing**

Until the cash in lieu amount is determined, the underlying price for FCNC1 will be determined as follows:

$$\text{FCNC1} = 0.062 (\text{FCNCA})$$

**Delayed Settlement**

The FCNCA component of the FCNC1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the FCNC1 deliverable until the cash in lieu of fractional FCNCA shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

**Background**

On February 9, 2021, Shareholders of CIT Group Inc. (CIT) voted concerning the proposed merger with First Citizens Bancshares, Inc. (FCNCA). The merger was approved and subsequently consummated on January 3, 2022. As a result, each existing CIT Common Share will be converted into the right to receive 0.062 FCNCA Class A Common Shares. Cash will be paid in lieu of fractional FCNCA shares.
