On December 1, 2021, Unitholders of Teekay LNG Partners L.P. (TGP) voted concerning the proposed merger with Limestone Merger Sub, Inc., a wholly-owned subsidiary of Stonepeak Limestone Holdings LP. The merger was approved and subsequently consummated before the open on January 13, 2022. As a result, each existing TGP Common Unit will be converted into the right to receive \$17.00 net cash per unit.

NEW DELIVERABLE

PER CONTRACT: \$1,700.00 Cash (\$17.00 x 100)

Settlement in TGP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Teekay LNG Partners L.P. options whose expiration dates are after 1-21-2022 will have their expiration dates advanced to 1-21-2022. Expiration dates occurring before 1-21-2022 (e.g., Flex options) will remain unchanged.

All Teekay LNG Partners L.P. options will utilize a \$.01 exercise threshold.

Existing American-style Teekay LNG Partners L.P. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
