Baudax Bio, Inc. (BXRX) has announced a 1-for-35 reverse stock split. As a result of the reverse stock split, each BXRX Common Share will be converted into the right to receive approximately 0.028571 (New) Baudax Bio, Inc. Common Shares. The reverse stock split will become effective before the market open on February 16, 2022.

### **Delayed Settlement**

The BXRX component of the BXRX1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the BXRX1 deliverable until the cash in lieu of fractional BXRX Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
