ZIM Integrated Shipping Services Ltd. (ZIM) has announced a \$17.00 dividend per each ZIM Ordinary Share in accordance with the company's dividend policy. NYSE has set March 22, 2022 as the exdistribution date for this distribution.

No Contract Adjustment for the ZIM Dividend

Pursuant to Article VI, Section 11A of OCC's By-laws, OCC has determined that ZIM options WILL NOT BE ADJUSTED FOR THE \$17.00 DIVIDEND. OCC has determined that the Cash Dividend is an ordinary dividend as defined in the OCC By-Laws for which no adjustment should be made.

Interpretations and Policies .01 to Article VI, Section 11A of the OCC By-Laws states:

... cash dividends or distributions (regardless of size) by the issuer of the underlying security which the Corporation believes to have been declared pursuant to a policy or practice of paying such dividends or distributions on a quarterly or other regular basis will, as a general rule, be deemed to be ordinary cash dividends or distributions within the meaning of paragraph (c) of Section 11A.
