On May 17, 2022, Shareholders of TEGNA Inc. (TGNA) will vote concerning the proposed merger with affiliates of CMG Media Corporation, which prior to and in connection with the merger, will become an affiliate of Standard General L.P. If the merger is approved and consummated, each existing TGNA Common Share will be converted into the right to receive \$24.00 net cash per share, subject to upward adjustment as described in the TGNA Proxy Statement dated April 13, 2022 (“Proxy”).

Contract Adjustment

Date: Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur in the second half of 2022.

New Deliverable
Per Contract: \$2,400.00 Cash (\$24.00 x 100), subject to upward adjustment as described in the Proxy

Settlement in TGNA options will take place through OCC’s cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
