Surgalign Holdings, Inc. (SRGA) has announced a 1-for-30 reverse stock split. As a result of the reverse stock split, each SRGA Common Share will be converted into the right to receive approximately 0.033333 (New) Surgalign Holdings, Inc. Common Shares. The reverse stock split will become effective before the market open on May 17, 2022. Cash will be paid in lieu of fractional shares.

Note: Once determined the cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

**Pricing**

Until the cash in lieu amount is determined, the underlying price for SRGA1 will be determined as follows:

$$\text{SRGA1} = 0.033333 (\text{SRGA})$$

**Delayed Settlement**

The SRGA component of the SRGA1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the SRGA1 deliverable until the cash in lieu of fractional SRGA Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
