On May 24, 2022, Potable Merger Sub, Inc., a wholly owned subsidiary of D.R. Horton, Inc., completed its tender offer for Vidler Water Resources, Inc. (VWTR). The subsequent merger was consummated before the open on May 25, 2022. As a result, each existing VWTR Common Share will be converted into the right to receive \$15.75 net cash per share.

## Contract Adjustment

NEW DELIVERABLE PER CONTRACT: \$1,575.00 Cash (\$15.75 x 100)

Settlement in Vidler Water Resources, Inc. options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Vidler Water Resources, Inc. options whose expiration dates are after 6-17-2022 will have their expiration dates advanced to 6-17-2022. Expiration dates occurring before 6-17-2022 (e.g., Flex options) will remain unchanged.

All Vidler Water Resources, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: VWTR Existing Expiration: All months New expiration date: 6-17-2022

Existing American-style Vidler Water Resources, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
