On August 24, 2021, the Libbie Shearn Moody Trust and The Moody Foundation, which as of that date, owned approximately 59.8% of issued and outstanding common shares of American National Group, Inc. (ANAT), delivered a written consent approving and adopting the merger agreement with Freestone Merger Sub Inc., a wholly-owned subsidiary of Brookfield Asset Management Reinsurance Partners Ltd. The merger was subsequently consummated before the open on May 25, 2022. As a result, each existing ANAT Common Share will be converted into the right to receive \$190.00 net cash per share.

Settlement in ANAT options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of American National Group, Inc. options whose expiration dates are after 6-17-2022 will have their expiration dates advanced to 6-17-2022. Expiration dates occurring before 6-17-2022 (e.g., Flex options) will remain unchanged.

All American National Group, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: ANAT Existing Expiration: All months New expiration date: 6-17-2022

Existing American-style American National Group, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
