Boqii Holding Limited (BQ) has announced an anticipated 1-for-6 reverse stock split (revised from 1-for-8). As a result of the reverse stock split, each BQ American Depositary Share will be converted into the right to receive approximately 0.166667 (New) Boqii Holding Limited American Depositary Shares. The reverse stock split is anticipated to become effective before the market open on June 3, 2022 (revised from May 31, 2022). It is anticipated that cash will be paid in lieu of fractional shares.

Delayed Settlement

The BQ component of the BQ1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the BQ1 deliverable until the cash in lieu of fractional BQ Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
