Subject: Adjusted Evofem Biosciences, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: EVFM1

Adjusted Evofem Biosciences, Inc. options were adjusted on May 6, 2022 (See OCC Information Memo #50374).

The new deliverable became 1) 6 Evofem Biosciences, Inc. (EVFM) Common Shares, 2) Cash in lieu of approximately 0.6667 fractional EVFM Shares. Only settlement of the cash portion of EVFM1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$1.65 per whole EVFM share will be used to determine the cash in lieu amount at a rate of 0.666667. Accordingly, the cash in lieu amount is:

$$0.666667 \times \$1.65 = \$1.10 \text{ per EVFM1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of May 6, 2022 through May 31, 2022, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the EVFM1 options are as follows:

New Deliverable

Per Contract: 1) 6 Evofem Biosciences, Inc. (EVFM) Common Shares
2) \$1.10 Cash

Strike Prices: Unchanged

CUSIP: EVFM: 30048L203

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The EVFM component of EVFM1 exercise/assignment activity from May 6, 2022 through May 27, 2022, has settled through National Security Clearing Corporation (NSCC). The \$1.10 cash amount will be settled by OCC.

Pricing

The underlying price for EVFM1 will be determined as follows:

$$\text{EVFM1} = 0.06 (\text{EVFM}) + 0.0110$$

For example, if EVFM closes at 0.347, the EVFM1 price would be calculated as follows:

$$\text{EVFM1} = 0.06 (0.347) + 0.0110 = 0.03$$
