Pennsylvania Real Estate Investment Trust (PEI) has announced a 1-for-15 reverse stock split. As a result of the reverse stock split, each PEI Share of Beneficial Interest will be converted into the right to receive approximately 0.066667 (New) Pennsylvania Real Estate Investment Trust Shares of Beneficial Interest. The reverse stock split will become effective before the market open on June 16, 2022.

Pricing

Until the cash in lieu amount is determined, the underlying price for PEI1 will be determined as follows:

$$\text{PEI1} = 0.066667 (\text{PEI})$$

Delayed Settlement

The PEI component of the PEI1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the PEI1 deliverable until the cash in lieu of fractional PEI Shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.
