Effective March 16, 2022, the National Securities Clearing Corporation ("NSCC") no longer accepted QIWI exercise and assignment activity for settlement. As a result, all exercise and assignment activity for QIWI options beginning March 16, 2022 were subject to broker to broker settlement, as stated in OCC Information Memos #50189 and #50212. **Effective with exercises of June 17, 2022 and thereafter, all QIWI exercise and assignment activity will be subject to delayed settlement.**

**Exercise and assignment activity for QIWI options between March 16, 2022 and June 16, 2022, will remain subject to broker to broker settlement.**

**The deliverable for QIWI options contracts will remain the underlying 100 QIWI American Depositary Shares.**
