On April 11, 2022, Majority Stockholders of Datto Holding Corporation (MSP), which as of that date owned approximately 69.1% of the aggregate voting power of the issued and outstanding shares of MSP, delivered a written consent approving and adopting the merger agreement with a wholly-owned subsidiary of Kaseya Inc., which is a subsidiary of Kaseya Holdings. The merger was subsequently consummated before the open on June 23, 2022. As a result, each existing MSP Common Share will be converted into the right to receive \$35.50 net cash per share.

Settlement in MSP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Datto Holding Corporation options whose expiration dates are after 7-15-2022 will have their expiration dates advanced to 7-15-2022. Expiration dates occurring before 7-15-2022 (e.g., Flex options) will remain unchanged.

All Datto Holding Corporation options will utilize a \$.01 exercise threshold.

Existing Expiration: All months
New expiration date: 7-15-2022

Existing American-style Datto Holding Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
