Pricing

Until the cash in lieu amount is determined, the underlying price for MATV1 will be determined as follows:

Delayed Settlement

The MATV component of the MATV1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the MATV1 deliverable until the cash in lieu of fractional MATV shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

Background

On June 29, 2022, Shareholders of Neenah, Inc. (NP) will vote concerning the proposed merger with Schweitzer-Mauduit International, Inc. (SWM). If the merger is approved and consummated, Schweitzer-Mauduit International, Inc. will change its name and trading symbol to **Mativ Holdings, Inc.** (MATV), and each existing NP Common Share will be converted into the right to receive 1.358 MATV Common Shares. Cash will be paid in lieu of fractional MATV shares.
