On June 30, 2022, Shareholders of GTY Technology Holdings Inc. (GTYH) voted concerning the proposed merger with a wholly-owned subsidiary of GI Georgia Midco, Inc., which is owned by investment funds advised by GI Manager, L.P. The merger was approved and subsequently consummated before the open on July 7, 2022. As a result, each existing GTYH Common Share will be converted into the right to receive \$6.30 net cash per share.

Settlement in GTYH options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

**Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of GTY Technology Holdings Inc. options whose expiration dates are after 7-15-2022 will have their expiration dates advanced to 7-15-2022. Expiration dates occurring before 7-15-2022 (e.g., Flex options) will remain unchanged.

All GTY Technology Holdings Inc. options will utilize a \$.01 exercise threshold.

New expiration date: 7-15-2022

Existing American-style GTY Technology Holdings Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
