Subject: Adjusted Global X Funds Global X Cannabis ETF – Cash In Lieu

Settlement

Adjusted Option Symbol: POTX1

Adjusted Global X Funds Global X Cannabis ETF options were adjusted on June 13, 2022 (See OCC Information Memo #50572).

The new deliverable became 1) 16 Global X Funds Global X Cannabis ETF (POTX) Shares and 2) Cash in lieu of approximately 0.6667 fractional POTX Shares. Only settlement of the cash portion of POTX1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$16.19 per whole POTX share will be used to determine the cash in lieu amount at a rate of 0.666667. Accordingly, the cash in lieu amount is:

0.666667 x \$16.19 = \$10.79 per POTX1 Contract

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of June 13, 2022 through July 14, 2022, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the POTX1 options are as follows:

New Deliverable

Per Contract: 1) 16 Global X Funds Global X Cannabis ETF (POTX) Shares

2) \$10.79 Cash

Strike Prices: Unchanged

CUSIP: POTX: 37954Y145

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The POTX component of POTX1 exercise/assignment activity from June 13, 2022 through July 13, 2022, has settled through National Security Clearing Corporation (NSCC). The \$10.79 cash amount will be settled by OCC.

Pricing

The underlying price for POTX1 will be determined as follows:

$$POTX1 = 0.16 (POTX) + 0.1079$$

For example, if POTX closes at 16.53, the POTX1 price would be calculated as follows:

$$POTX1 = 0.16 (16.53) + 0.1079 = 2.75$$
