Settlement/Acceleration of Expirations

On July 13, 2022, Tidal ETF Trust announced that it will terminate and subsequently liquidate the SonicShares Airlines, Hotels, Cruise Lines ETF (TRYP). The last day of trading for the TRYP shares on the New York Stock Exchange was July 22, 2022 (the “Closing Date”). Shareholders could sell their holdings in TRYP prior to the Closing Date. From July 22, 2022 through July 29, 2022 (the “Liquidation Date”), shareholders were able to sell their shares only to certain broker-dealers, and there was no assurance that there would be a market for the TRYP shares during that time period.

On or about the Liquidation Date, TRYP will liquidate its assets and distribute cash pro rata to all shareholders of record who have not previously redeemed or sold their shares, subject to any required withholding.

The per share liquidation amount has been determined to be \$3.65613838 cash per TRYP share.

Contract Adjustment

The option symbol TRYP will not change.

TRYP options, which were subject to delayed settlement from July 25, 2022 through July 29, 2022, are no longer subject to delayed settlement, effective August 1, 2022.

Settlement in the TRYP options will take place through OCC’s cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of SonicShares Airlines, Hotels, Cruise Lines ETF options whose expiration dates are after 8-19-2022 will have their expiration dates advanced to 8-19-2022. Expiration dates occurring before 8-19-2022 (e.g., Flex options) will remain unchanged.

All SonicShares Airlines, Hotels, Cruise Lines ETF options will utilize a \$.01 exercise threshold.

Option Symbol: TRYP

Existing Expiration: All months

New expiration date: 8-19-2022

Existing American-style SonicShares Airlines, Hotels, Cruise Lines ETF options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
