Subject: Metromile, Inc. - Cash In Lieu Settlement

Adjusted Option Symbol: LMND1

Metromile, Inc. options were adjusted on July 28, 2022 (See OCC Information Memo #50792). The new deliverable became 1) 5 Lemonade, Inc. (LMND) Common Shares, and 2) Cash in lieu of 0.263 fractional LMND Common Shares. Only settlement of the cash portion of LMND1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$17.27 per whole LMND share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

 $0.263 \times 17.27 = 4.54 \text{ per LMND1 Contract}$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of July 28, 2022 through August 03, 2022, to deliver the appropriate cash amount

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the LMND1 options are as follows:

New Deliverable

Per Contract: 1) 5 Lemonade, Inc. (LMND) Common Shares

2) \$4.54 Cash

Strike Prices: Unchanged

CUSIP: LMND: 52567D107

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The LMND component of LMND1 exercise/assignment activity from July 28, 2022 through August 2, 2022, has settled through National Security Clearing Corporation (NSCC). The \$4.54 cash amount will be settled by OCC.

Pricing

The underlying price for LMND1 will be determined as follows:

LMND1 = 0.05 (LMND) + 0.0454

For example, if LMND closes at 21.60, the LMND1 price would be calculated as follows:

LMND1 = 0.05 (21.60) + 0.0454 = 1.13
