On June 30, 2022, Shareholders of SailPoint Technologies Holdings, Inc. (SAIL) voted concerning the proposed merger with an affiliate of Thoma Bravo Fund XV, L.P., a fund affiliated with Thoma Bravo, L.P. The merger was approved and subsequently consummated before the open on August 16, 2022. As a result, each existing SAIL Common Share will be converted into the right to receive \$65.25 net cash per share.

Settlement in SAIL options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of SailPoint Technologies Holdings, Inc. options whose expiration dates are after 8-19-2022 will have their expiration dates advanced to 8-19-2022. Expiration dates occurring before 8-19-2022 (e.g., Flex options) will remain unchanged.

All SailPoint Technologies Holdings, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style SailPoint Technologies Holdings, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
