On August 15, 2022, Rhumba Merger Sub, Inc., a wholly owned subsidiary of Bristol-Myers Squibb Company, completed its tender offer for Turning Point Therapeutics, Inc. (TPTX). The subsequent merger was consummated before the open on August 17, 2022. As a result, each existing TPTX Common Share will be converted into the right to receive \$76.00 net cash per share.

Settlement in Turning Point Therapeutics, Inc. options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Turning Point Therapeutics, Inc. options whose expiration dates are after 9-16-2022 will have their expiration dates advanced to 9-16-2022. Expiration dates occurring before 9-16-2022 (e.g., Flex options) will remain unchanged.

All Turning Point Therapeutics, Inc. options will utilize a \$.01 exercise threshold.

Existing American-style Turning Point Therapeutics, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
