On August 16, 2022, Unitholders of Blueknight Energy Partners, L.P. (BKEP) voted concerning the proposed merger with Merle, LLC, a wholly-owned subsidiary of Ergon Asphalt & Emulsions, Inc. The merger was approved and subsequently consummated on August 17, 2022. As a result, each existing BKEP Common Unit will be converted into the right to receive \$4.65 net cash per unit.

Settlement in BKEP options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Blueknight Energy Partners, L.P. options whose expiration dates are after 9-16-2022 will have their expiration dates advanced to 9-16-2022. Expiration dates occurring before 9-16-2022 (e.g., Flex options) will remain unchanged.

All Blueknight Energy Partners, L.P. will utilize a \$.01 exercise threshold.

New expiration date: 9-16-2022

Existing American-style Blueknight Energy Partners, L.P. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
