On August 19, 2022, Raven Houston Merger Sub, Inc., a wholly owned subsidiary of Raven Buyer, Inc., completed its tender offer for Sharps Compliance Corporation (SMED). The subsequent merger was consummated before the open on August 23, 2022. As a result, each existing SMED Common Share will be converted into the right to receive \$8.75 net cash per share.

Contract Adjustment

Settlement in SMED options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Sharps Compliance Corporation options whose expiration dates are after 9-16-2022 will have their expiration dates advanced to 9-16-2022. Expiration dates occurring before 9-16-2022 (e.g., Flex options) will remain unchanged.

All Sharps Compliance Corporation options will utilize a \$.01 exercise threshold.

Option Symbol: SMED Existing Expiration: All months New expiration date: 9-16-2022

Existing American-style Sharps Compliance Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
