Subject: Tufin Software Technologies Ltd. – Cash Settlement Option Symbols: TUFN/1TUFN Date: 08/25/2022

On June 7, 2022, Shareholders of Tufin Software Technologies Ltd. (TUFN) approved the proposed merger with a wholly-owned subsidiary of Talon MidCo 3 Limited, a subsidiary of investment funds advised by Turn/River Capital Management LP. The merger was subsequently consummated before the open on August 25, 2022. As a result, each existing TUFN Ordinary Share will be converted into the right to receive \$13.00 net cash per share, less withholdings, if any.

NOTE: Tufin Software Technologies Ltd. intends to submit an application to the Israeli Tax Authority which includes a request that non-Israeli shareholders be exempt from Israeli withholding, if such stockholders will provide the paying agent in Israel with certain declarations and supporting documents regarding their residency and the date on which their shares were purchased, and satisfy other conditions as stated in the TUFN Proxy Statement dated May 13, 2022 ("Proxy"). Investors are referred to the Proxy for a complete discussion of relevant tax considerations. As indicated below, the deliverable of adjusted TUFN options will be based on the merger consideration net of applicable withholding taxes, if any.

Contract Adjustment

NEW DELIVERABLE PER CONTRACT:	\$1,300.00 Cash (\$13.00 x 100), less withholdings, if any
SETTLEMENT:	OCC will delay settlement of TUFN/1TUFN deliverable until the final net cash merger consideration is confirmed.

Once the final amount is determined, settlement in TUFN/1TUFN options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23988)
