On June 23, 2022, Shareholders of Plantronics, Inc. (POLY) voted concerning the proposed merger with Prism Subsidiary Corporation, a wholly-owned subsidiary of HP Inc. The merger was approved and subsequently consummated before the open on August 29, 2022. As a result, each existing POLY Common Share will be converted into the right to receive \$40.00 net cash per share.

Contract Adjustment

NEW DELIVERABLE

PER CONTRACT: \$4,000.00 Cash (\$40.00 x 100)

Settlement in POLY options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Plantronics, Inc. options whose expiration dates are after 9-16-2022 will have their expiration dates advanced to 9-16-2022. Expiration dates occurring before 9-16-2022 (e.g., Flex options) will remain unchanged.

All Plantronics, Inc. options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 9-16-2022

Existing American-style Plantronics, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
