On August 22, 2022, E.Merge Technology Acquisition Corporation (ETAC) announced it will redeem all its outstanding Class A Common Shares at a rate of approximately \$10.06 Cash per share. ETAC shares were suspended from trading on NASDAQ before the open on September 6, 2022.

The redemption amount has been determined to be \$10.07087949 per ETAC share.

Contract Adjustment

The option symbol ETAC will not change.

New Deliverable
Per Contract: \$1,007.09 Cash ($\10.07087949×100)

ETAC options, which were subject to delayed settlement from September 6, 2022 through September 9, 2022, will no longer be subject to delayed settlement, effective September 12, 2022.

Settlement in the ETAC options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash-only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of E.Merge Technology Acquisition Corporation options whose expiration dates are after 9-16-2022 will have their expiration dates advanced to 9-16-2022. Expiration dates occurring before 9-16-2022 (e.g., Flex options) will remain unchanged.

All E.Merge Technology Acquisition Corporation options will utilize a \$.01 exercise threshold.

Existing American-style E.Merge Technology Acquisition Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
