On October 10, 2022, Shareholders of Meridian Bioscience, Inc. (VIVO) will vote concerning the proposed merger with a wholly-owned subsidiary of Columbus Holding Company, an affiliate of SD Biosensor, Inc. and SJL Partners, LLC. If the merger is approved and consummated, each existing VIVO Common Share will be converted into the right to receive \$34.00 net cash per share.

## Contract Adjustment

Effective the opening of the business day after the merger is consummated. Contract adjustment is expected to occur in the fourth quarter of 2022.

 \$3,400.00 Cash (\$34.00 x 100)

Settlement in VIVO options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## **Acceleration of Expirations**
