On September 12, 2022, Shareholders of USA Truck, Inc. (USAK) voted concerning the proposed merger with a wholly-owned subsidiary of Schenker, Inc., a subsidiary of DB Schenker. The merger was approved and subsequently consummated before the open on September 15, 2022. As a result, each existing USAK Common Share will be converted into the right to receive \$31.72 net cash per share.

Contract Adjustment

Settlement in USAK options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of USA Truck, Inc. options whose expiration dates are after 10-21-2022 will have their expiration dates advanced to 10-21-2022. Expiration dates occurring before 10-21-2022 (e.g., Flex options) will remain unchanged.

All USA Truck, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: USAK Existing Expiration: All months New expiration date: 10-21-2022

Existing American-style USA Truck, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
