## **Delayed Settlement**

The MTZ component of the MTZ1 deliverable will settle through National Securities Clearing Corporation (NSCC). OCC will delay settlement of the cash portion of the MTZ1 deliverable until the cash in lieu of fractional MTZ shares is determined. Upon determination of the cash in lieu amount, OCC will require Put exercisers and Call assignees to deliver the appropriate cash amount.

## **Background**

On October 7, 2022, Shareholders of Infrastructure and Energy Alternatives, Inc. (IEA) will vote concerning the proposed merger with MasTec, Inc. (MTZ). If the merger is approved and consummated, each existing IEA Common Share will be converted into the right to receive 0.0483 MTZ Common Shares plus \$10.50 Cash. Cash will be paid in lieu of fractional MTZ shares.
