Mudrick Capital Acquisition Corporation II (MUDS) announced it will redeem all its outstanding Class A Common Shares at a rate of approximately \$10.16 Cash per share ("Redemption Amount"). MUDS shares were suspended from trading on NASDAQ before the open on September 13, 2022.

The redemption amount has been determined to be \$10.18304895 per MUDS share.

## **Contract Adjustment**

The option symbol MUDS will not change.

MUDS options, which were subject to delayed settlement from September 13, 2022 through September 22, 2022, will no longer be subject to delayed settlement, effective September 23, 2022.

Settlement in MUDS options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

## Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Mudrick Capital Acquisition Corporation II options whose expiration dates are after 10-21-2022 will have their expiration dates advanced to 10-21-2022. Expiration dates occurring before 10-21-2022 (e.g., Flex options) will remain unchanged.

All Mudrick Capital Acquisition Corporation II options will utilize a \$.01 exercise threshold.

Existing American-style Mudrick Capital Acquisition Corporation II options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
