On September 23, 2022, TPG Pace Beneficial Finance Corporation (TPGY) announced it will redeem all its outstanding Class A Ordinary Shares at a rate of approximately \$10.01 per share (the "Redemption Amount").

TPGY shares will be suspended from trading on the New York Stock Exchange before the open on October 10, 2022. As of October 11, 2022, each TPGY share will be converted into the right to receive the Redemption Amount.

Contract Adjustment

The option symbol TPGY will not change.

Date: October 11, 2022

New Deliverable

Per Contract: Approximately \$1,001.00 Cash (\$10.01 x 100)

Settlement: TPGY options will be subject to delayed settlement effective October 11,

2022, until the final Redemption Amount is determined.

Once the final deliverable is determined, settlement in TPGY options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to **an acceleration of the expiration dates for outstanding option series** (See OCC Information Memo 23988).
