On September 23, 2022, TPG Pace Beneficial Finance Corporation (TPGY) announced it will redeem all its outstanding Class A Ordinary Shares at a rate of approximately \$10.01 per share (the "Redemption Amount").

TPGY shares were suspended from trading on the New York Stock Exchange before the open on October 10, 2022. As of October 11, 2022, each TPGY share will be converted into the right to receive the Redemption Amount.

The Redemption Amount has been determined to be \$10.05755431 per TPGY share.

#### **Contract Adjustment**

The option symbol TPGY will not change.

**Date:** October 11, 2022

#### **New Deliverable**

**Per Contract:** \$1,005.76 Cash (\$10.05755431 x 100)

Settlement in TPGY options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

#### **Acceleration of Expirations**

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cash only delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of TPG Pace Beneficial Finance Corporation options whose expiration dates are after 10-21-2022 will have their expiration dates advanced to 10-21-2022. Expiration dates occurring before 10-21-2022 (e.g., Flex options) will remain unchanged.

All TPG Pace Beneficial Finance Corporation options will utilize a \$.01 exercise threshold.

Existing Expiration: All months  
New expiration date: 10-21-2022

Existing American-style TPG Pace Beneficial Finance Corporation options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
