On October 13, 2022, NNUS New Dev, Inc., an indirect wholly owned subsidiary of Novo Nordisk A/S, completed its tender offer for Forma Therapeutics Holdings, Inc. (FMTX). The subsequent merger was consummated before the open on October 14, 2022. As a result, each existing FMTX Common Share will be converted into the right to receive \$20.00 net cash per share.

Contract Adjustment

Settlement in FMTX options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Forma Therapeutics Holdings, Inc. options whose expiration dates are after 10-21-2022 will have their expiration dates advanced to 10-21-2022. Expiration dates occurring before 10-21-2022 (e.g., Flex options) will remain unchanged.

All Forma Therapeutics Holdings, Inc. options will utilize a \$.01 exercise threshold.

Option Symbol: FMTX Existing Expiration: All months New expiration date: 10-21-2022

Existing American-style Forma Therapeutics Holdings, Inc. options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
