Social Capital Hedosophia Holdings Corporation VI (IPOF) announced it will redeem all its outstanding Class A Ordinary Shares at a rate of approximately \$10.01 Cash per share (the "Redemption Amount").

IPOF shares ceased trading on the New York Stock Exchange as of the close of business on October 14, 2022. As of October 17, 2022, each IPOF share will be converted into the right to receive the Redemption Amount.

The Redemption Amount has been determined to be \$10.05950695 per IPOF share.

Contract Adjustment

The option symbol IPOF will not change.

New Deliverable

Per Contract: \$1,005.95 Cash (\$10.05950695 x 100)

Settlement in IPOF options will take place through OCC's cash settlement system. Settlement will be accomplished by payment of the difference between the extended strike amount and the cash deliverable.

Acceleration of Expirations

Pursuant to OCC Rule 807, equity stock option contracts whose deliverables are adjusted to call for cashonly delivery will be subject to an acceleration of the expiration dates for outstanding option series. (See OCC Information Memo 23707) Additionally, the exercise by exception (ex by ex) threshold for expiring series will be \$.01 in all account types.

All series of Social Capital Hedosophia Holdings Corporation VI options whose expiration dates are after 10-21-2022 will have their expiration dates advanced to 10-21-2022. Expiration dates occurring before 10-21-2022 (e.g., Flex options) will remain unchanged.

All Social Capital Hedosophia Holdings Corporation VI options will utilize a \$.01 exercise threshold.

Existing Expiration: All months New expiration date: 10-21-2022

Existing American-style Social Capital Hedosophia Holdings Corporation VI options remain exercisable at the option of the holder prior to their expiration. Exercised options will continue to settle in two business days.
