Subject: Allegiance Bancshares, Inc. – Cash In Lieu Settlement
Adjusted Option Symbol: STEL1

Allegiance Bancshares, Inc. options were adjusted on October 3, 2022 (See OCC Information Memo #51114). The new deliverable became 1) 141 Stellar Bancorp (STEL) Common Shares, and 2) Cash in lieu of 0.84 fractional STEL Common Shares. Only settlement of the cash portion of STEL1 options exercise/assignment activity was subject to delayed settlement.

OCC has been informed that a price of \$26.07 per whole STEL share will be used to determine the cash in lieu amount. Accordingly, the cash in lieu amount is:

$$0.84 \times \$26.07 = \$21.90 \text{ per STEL1 Contract}$$

Now that the exact cash in lieu amount has been determined, OCC will require Put exercisers and Call assignees, during the period of October 3, 2022 through October 20, 2022, to deliver the appropriate cash amount.

The cash in lieu of fractional share portion of the option deliverable remains fixed and does not vary with price changes of any security.

Terms of the STEL1 options are as follows:

New Deliverable

Per Contract: 1) 141 Stellar Bancorp (STEL) Common Shares
2) \$21.90 Cash

Strike Prices: Unchanged

CUSIP: STEL: 858927106

Multiplier: 100 (i.e., a premium of 1.50 yields \$150)

Settlement

The STEL component of STEL1 exercise/assignment activity from October 3, 2022 through October 19, 2022, has settled through National Security Clearing Corporation (NSCC). The \$21.90 cash amount will be settled by OCC.

Pricing

The underlying price for STEL1 will be determined as follows:

$$\text{STEL1} = 1.41 (\text{STEL}) + 0.2190$$

For example, if STEL closes at 28.85, the STEL1 price would be calculated as follows:

$$\text{STEL1} = 1.41 (28.85) + 0.2190 = 40.90$$
